#### Will BAIC build a battery cell plant in Beijing?

BAIC is joining forces with CATL and Xiaomi Auto to build a battery cell plant in Beijing. The three companies are setting up a joint venture called Beijing Era New Energy Technology, which will have capital totalling one billion yuan (138 million US dollars).

#### What is BAIC bluepark new energy technology?

On the evening of March 11th, BAIC BluePark New Energy Technology announced that to ensure a stable supply of power batteries and support industrial development, the company plans to establish a platform company in partnership with BAIC Investment, Beijing Hainachuan.

News reports suggest that BAIC Group's BluePark New Energy Technology is establishing a platform companyin partnership with BAIC Investment, Beijing Hainachuan to serve as the management and investment agency for the battery JV. BluePark is the manufacturer of Arcfox brand of EVs sold in China.

#### Are BAIC investment and Beijing hainachuan related parties?

According to the announcement, BAIC Investment and Beijing Hainachuan are related parties of BAIC BluePark, constituting a related party joint investment transaction. BAIC BluePark is in the new energy vehicle business with the popular brand Arcfox.

In terms of vehicle loading, in April, the Zhiji L6 started pre-sales, equipped with a quasi-900V ultra-fast charging semi-solid-state battery, which was jointly developed by Qingtao Energy. In February, BAIC Blue Valley said that the company was actively carrying out solid-state battery verification tests.
