

# Contents of the energy storage environmental impact report

The drop in energy consumption in 2019-20 was 182 petajoules: the same amount of energy from filling a 55-litre tank of petrol 97 million times. Energy productivity (gross domestic product (GDP) divided by energy consumption) improved by 2.7 per cent in 2019-20 and by 21 per cent over the past ten years.

In 2012 the Commission adopted a proposal to amend Directive 2011/92/EU based on a thorough impact assessment. The aim was to lighten unnecessary administrative burdens, reinforce the decision-making process and make it easier to assess potential impacts without weakening existing environmental safeguards.
