All claims must be validated by the customs authority (either digitally or physically) before you leave the EU.

Can a non-EU business get a VAT refund?

Non-EU businesses that incur VAT in connection with their activities in an EU Member State where they do not habitually supply goods or services (and are thus not required to register for VAT) are nevertheless entitled to obtain a refundfrom the EU Member State where they incurred the VAT.
