How do I report unused energy credits?

As a cooperative, see the instructions for Form 3800, Part III, line 1a, for allocating the investment credit to your patrons. If you have any unused credits from cooperatives, see the General Instructions for filing Form 3468 to report them.

What is the capacity limit for waste energy recovery property?

The term "waste energy recovery property" shall not include any property that has a capacity in excess of 50 megawatts. Qualified waste energy recovery property means property that generates electricity solely from heat from buildings or equipment if the primary purpose of such building or equipment is not the generation of electricity.

Can a partnership transfer energy credit to a facility?

If you are a partnership electing to transfer the energy creditwith respect to a facility or property under section 6418 (c), you must report the total credit amount on line 32 and Form 3800, Part III, line 4a.
