Why are battery energy storage systems not being developed in Italy?

The development of Battery Energy Storage Systems (hereinafter "BESS") in Italy has been limited by the fact that the spread of renewable sources is not such as to produce significant price differences during the hours of the day yet. An unfavourable legal and regulatory framework has also contributed to the low diffusion of BESS.

Why is Italy an attractive market for energy storage systems?

How does Italy guarantee a long-term supply system of new storage capacity?

The Italian legislator has acted to guarantee a long-term supply system of new storage capacity by introducing a mechanism based on competitive,transparent and non-discriminatory auctions. The system recognises the right to an annual remuneration, in exchange for the provision of the awarded capacity as part of the national energy market.

Can batteries be used for energy storage in Italy?

In Italy, batteries have become an attractive technology for electricity storage projects although they are not traditionally used.
