A back-door listing is a method for converting a private company into a publicly traded company which bypasses the normal listing requirements of the stock exchange chosen.

Listing is a symbol of prestige for many companies, but getting one has not always been a walk in the park. In years past, some Chinese companies walked through the backdoor instead by listing via reverse takeovers--stock mergers where sellers of private target companies obtain majority shareholding in listed acquirors.
