How do government subsidies help energy storage enterprises?

Government subsidies alleviate the financial constraints of energy storage enterprises. Government subsidies promote R&D investment in energy storage enterprises. Differentiated subsidy strategies can generate higher TFP improvement returns. Government subsidies are an important means to guide the development of the energy storage industry.

Do government subsidies increase total factor productivity of energy storage enterprises?

Based on panel data of Chinese 101 energy storage enterprises from 2007 to 2022, this paper examines the effectiveness of government subsidies in the energy storage industry from the perspective of total factor productivity (TFP). The results unveil that government subsidies significantly increase the TFP of ESEs.

Is government's "picking winners" subsidy strategy effective in energy storage industry?
